Opće informacije

- Forscope pruža sljedeću dokumentaciju za **Microsoftove trajne softverske proizvode**. Licence drugih proizvođača softvera dolaze s različitim vrstama dokumentacije.
- Ne postoji službeni predložak za vizualni izgled dokumentacije, stoga se ona može razlikovati u pogledu grafičkog dizajna. Međutim, činjenični sadržaj je uvijek isti te potvrđuje ispunjenje zakonom propisanih uvjeta za prijenos vlasništva softvera.

- 3 Proizvod je trajan bez vremenskog ograničenja korištenja.
